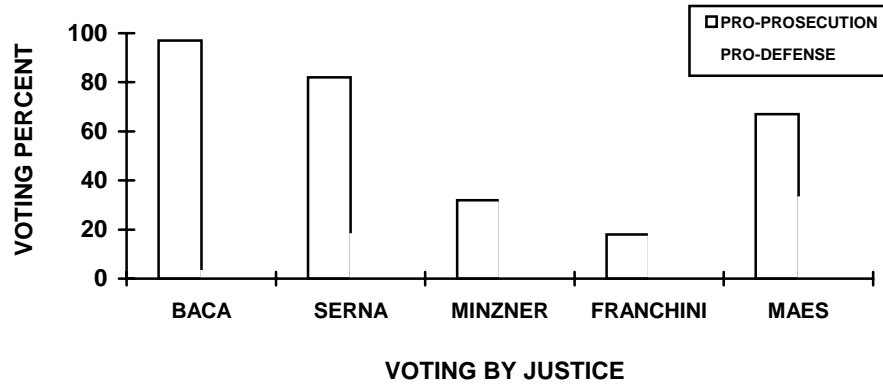


TABLE II: NEW MEXICO SUPREME COURT  
VOTING PATTERNS IN CIVIL CASES 1997-2002

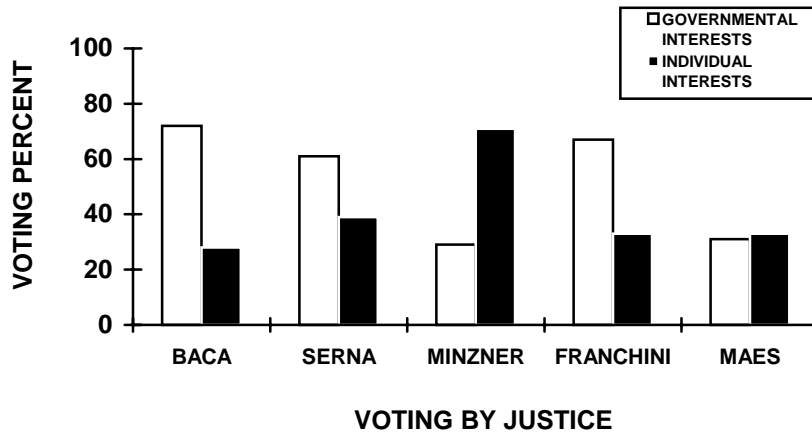


TABLE III: COMPARATIVE VOTING OF THE JUSTICES IN CRIMINAL CASES 1997-2002

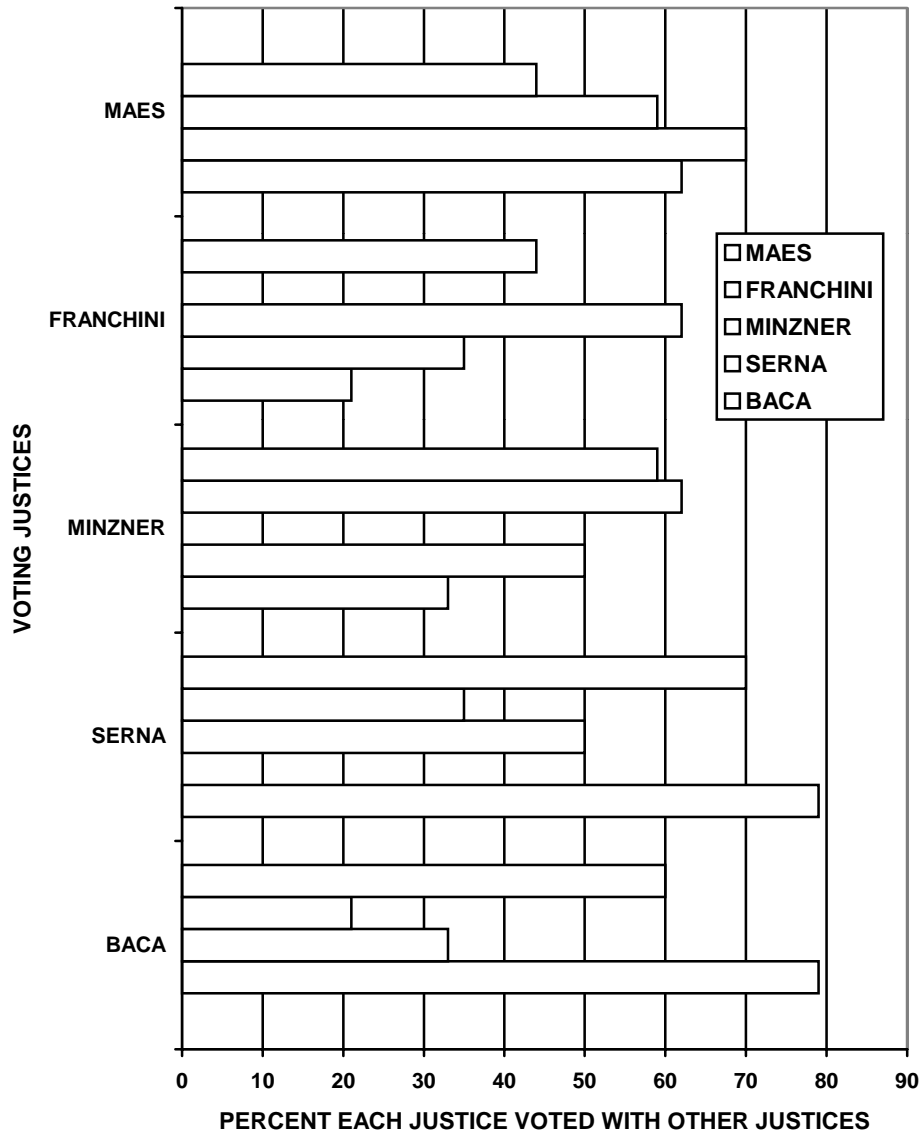
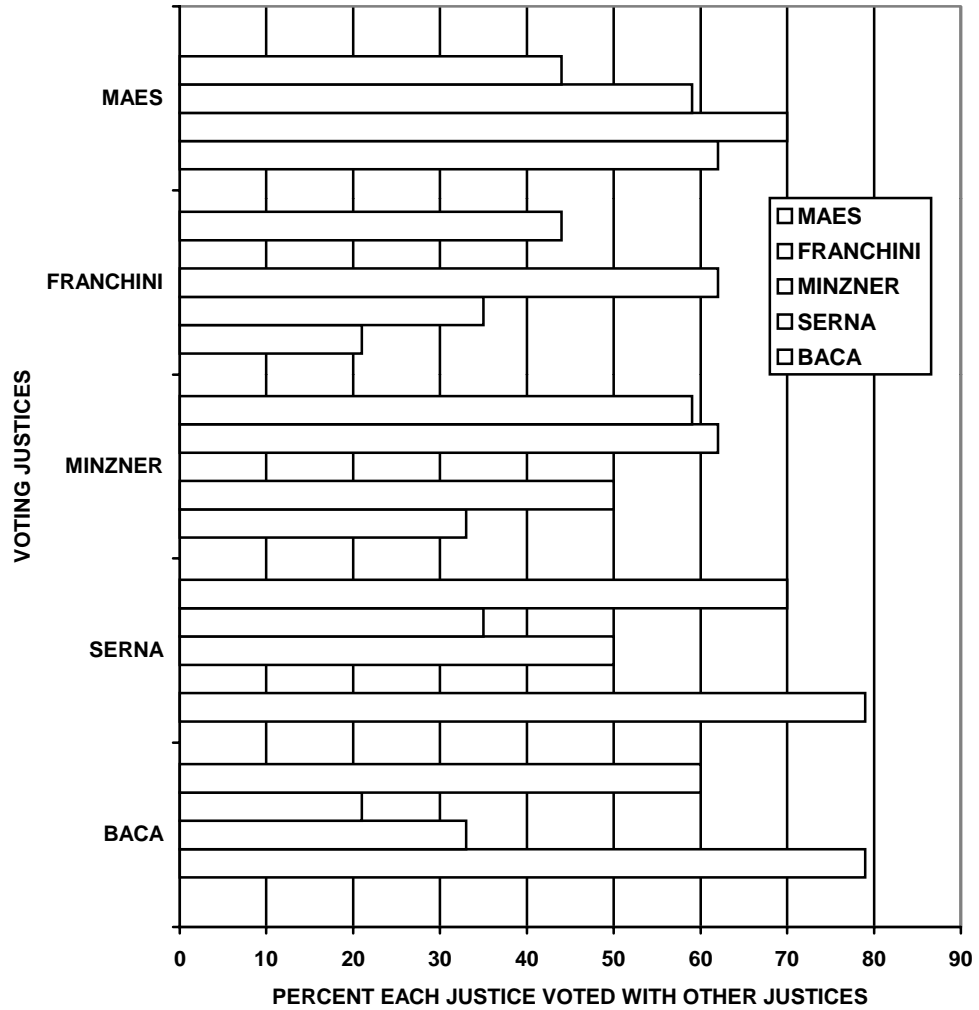


TABLE IV: COMPARATIVE VOTING OF THE JUSTICES IN CIVIL CASES 1997-2002
